FRC is also authorized to form committee and technical committee especially under section 17 (1) (2) and to execute functions of investigation, litigations & judicial proceedings under sections-(8)(1)(2S),48, 49 and 54 of the Act. **Now, FRC is requesting application from qualified Lawyer's for enlistment as Panel Lawyer under the following procedure, terms and conditions:**

#### Procedure of application:

Application must be submitted by post/courier **within 25<sup>th</sup> of January, 2021** to the Chairman, Financial Reporting Council along with Curriculum Vitae (CV) with personal details & **attested copies** of all academic Certificates, Mark Sheets, Bar Council Enrolment Certificate, Certificate of High Court Permission Test (if any), Appellate Division Enrolment (if any), Testimonial from concern Bar Association as a Member, NID, Two copies passport size photograph, Experience Certificates (enlistment to any other organizations, if any);

#### Terms and conditions /Terms of references:

01. Applicant must be enrolled in the Bangladesh Bar Council with minimum 05 (five) years of experiences (on the date of publishing this advertisement) of working in the relevant field with profound knowledge in Company Law, Banking Law, Commercial Law, Securities Law, Civil Law, Criminal Law, Land Law, Procurement Law, Financial Reporting, Auditing and Employment related Laws;
02. Applicant need to appear for an interview and he/she shall be engaged on case to case basis as decided by FRC from time to time, if selected;
03. Applicant shall not be entitled for TA, DA or honorarium or fees or remuneration or payment before or after enlistment except for fees applicable under chart of fees of FRC/legal fees against specific assignment given by the FRC from time to time;
04. Enlisted Panel Lawyer shall not practice or engage or act or commit anything against the interest of the FRC or its subsidiaries or associates;
05. Applicant, if selected, have to sign an undertaking in Tk. 300/- non judicial stamp paper with terms and conditions as fixed by FRC for safeguarding interest of the FRC. Panel Lawyer have to maintain secrecy, confidentiality and to act as custodian of FRC document/Case file , if engaged;
06. Panel Lawyer shall appear and attend in Court proceedings and in any or all meeting of the FRC for which he/she will be invited and also to update suit/case statements in prescribed format of FRC, if engaged;
07. The FRC/Selection Committee reserves every rights to accept or reject any application or to cancel/ terminate any engagement, if necessary, without notice or showing any grounds;
